



## **Bob Gurr**

Former Walt Disney Imagineer 1997 Disneyana Fan Club Legand



Iconic Imagineer and Disney Legend, Bob Gurr, is the only remaining orignal Imagineer among those assigned by Walt Disney to design Disneyland in 1954. His most famous work was for Walt Disney's Disneyland Park, and its subsquent sister Parks. Bob is said to have designed most, if not all, of the ride vehicles of the Disneyland attractions, including the Autopia cars, Haunted Mansion doom buggies, the Disneyland Monorail, the Submarine Voyage, and the Matterhorn Bobsleds and many more. Bob also developed the first realistic humanoid animatronic. Mr. Lincoln for Great Moments with Mr. Lincoln.

Bob received the prestigious Disney Legend Award in 2004 and his handprint s adorn the Court of Legends at the Walt Disney Studios in Burbank. In addition, he has the distinct honor of having a window on Main Street USA in both Disneyland and The Magic Kingdom. Apart from Disney, Bob designed the King Kong Encounter animatronic for Universal Studios Hollywood, the flying UFO for the opening ceremonies of the 1984 Olympic Games in Los Angeles, assisted Steven Spielberg in preproduction for the Jurassic Park T-Rex animatronic dinosaur, effects for Michael Jackson's Victory tour, as well as countless other projects and attractions that have entertained us for years and will continue to live on for generations to come.

### **GUEST SPEAKERS**

Disneyana Fan Club's Disney Legend Garner Holt will also be presenting at our special event.

Garner and his company, Garner Holt Productions, have been involved in designing and imagineering some of the most intricate, extremely complicated and amazing audio-animatronics that can be found in Disney Parks worldwide and other theme parks. It's always fascinating and entertaining to hear Garner speak about the details and engineering that go into the magic.

He founded Garner Holt Productions in 1977, when he was still in high school. Garner started the company in his parents' garage—with his mother acting as secretary! — and built it to a giant production facility, studio, and mockup space where they operate today with the help of nearly a hundred talented employees.

In Garner's own words, here's a description of the company that he created at the age of 17, "With a mission to inform, educate, and entertain, I believe our work and our creations have a lasting impact on our audience. This company is my main focus, my pride and joy, and, if I may brag a little, the most unique and talented group in the world. We've built nearly 500 Chuck E. Cheese animatronic shows for restaurants all over the planet. We were the first outside company to create an animatronic character for a classic Disney attraction--we now have more than 400 figures in Disney parks throughout the world. In our more than three decades of work, we've built more animatronics and other unusual and amazing creations than any organization on the planet."

## Kim Irvine

Walt Disney Imagineer

For the last four decades, Kim Irvine, Art Director, at Walt Disney Imagineering, has led a team in Anaheim responsible for maintaining the look, tone, and feel fo Disney'lands, Disney's original park. She is also working on Disenyland projects of adding a renewed Toon Town and greener Downtown Disney.

She guided Disneyland through the re-introduction of Abraham Lincoln, and the arrival of "Star Wars" and Indiana Jones properties. Later, she moved a river to accommodate Galaxy's Edge. Prior to the opening of Galaxy's Edge, she refurbished the Sleeping Beauty Castle, her sixth castle refurbishment. Known as a prominent Imagineer for her work on the Haunted Mansion, Pirates of the Caribbean, and the Disney apartment above Pirates, among other work, Irvine's talent has become legendary. The Disneyana Fan Club is proud to have selected her as one of our Legends for our May Event. She is the Daughter of Imagineer Leota Toombs, best known for providing the face of Madame Leota and Little Leota in the Haunted Mansion.

## **Leota Toombs**

Leota Toombs Thomas passed away on December 21, 1991

Toombs is best know for serving as the model for the character Madame Leota in the Haunted Mansion attraction. She was officially named a Disney Legend for her contributions in the categories of Attractions and Imagineering in 2009.

She began her career at the Walt Disney Studios in 1940, when she was hired into the Ink and Paint Department. She then transferred to the Animation Department, where she met animator Harvey Toombs, whom she married in 1947. She left the Company to raise their two children: Launie and Kim, but returned to Disney in 1962. Leota joined WED Enterprise, now known as Walt Disney Imagineering. While there, she created and developed designs for the 1964-1965 New York World's Fair, played pivotal roles in the creating of It's a Small World, Great Moments with Mr. Lincoln, and the Ford Magic Skyway. After the World's Fair ended, Leota transferred her talents to some of the most beloved attractions at Disneyland, including Pirates of the Caribbean and The Haunted Mansion. Her daughter, Kim Irvine, is also an Imagineer, starting with the company in 1970.



Read carefully: This is important information and is part of your Exhibitor contract

- Only current members of the Disneyana Fan Club are permitted to sell at this event. Membership
  must be valid through September for the September event and through February for the February
  event. Information on joining or renewing membership may be obtained at
  www.disneyanafanclub.org or by emailing membership@disneyanafanclub.org.
- The State of California requires each exhibitor to have a valid resale permit. A photocopy of this permit must accompany your table request and the resale permit number must appear on your Exhibitor Contract. We cannot provide sales space without the photocopy of the permit. Failure to provide a valid license by MAY 1, 2022 will result in forfeture of your table space and your payment. No refund will be issued. Contact the California State Board of Equalization for information on obtaining a resale number. You can contact them on-line at www.boe.ca.gov. You should also bring the resale document with you the day of the Show for possible inspection by State BOE personnel. Collection and payment of all applicable sales tax is the sole responsibility of the exhibitor.
- If you are unable to participate in this event after purchasing sales space, contact the Disneyana Fan Club as soon as possible. No refunds will be possible after the applicable deadline. Table space is non-transferable. All tables are assigned or reassigned by the Disneyana Fan Club.
- You are permitted <u>one helper</u> for each sales space purchased. Additional helpers are \$25.00 each
  or they may wait and pay the standard entry fee to be admitted in at 9:00am if they are a Disneyana
  Fan Club member or at 10:30am if they are not.
- We will make every attempt to honor special requests, such as wall space or electrical outlets, on a
  "First Come, First Served" basis. Priority is determined by the date on which we receive your
  completed contract and payment. Requests to have a sales space next to another exhibitor cannot
  be guaranteed unless both contracts are submitted in the same envelope. Those of you who have
  sold at our shows in the past know that location is not as important as having the merchandise
  collectors desire.
- This event will be held at the DoubleTree Suites by Hilton in Orange, California on the date noted.
   The hotel is about two miles southeast of Disneyland on the southwest corner of Chapman Avenue and The City Drive at 100 The City Drive, Orange, California 92868.
- Parking is available in lots adjacent to and directly behind the hotel. The sales rooms are on the first floor. After unloading, vehicles must be removed from the hotel driveway areas. Failure to do so may result in the vehicle being towed away at the owner's expense.
- Please stop at the Check-In Table, before you begin to unload, to verify your table assignment(s) and receive your identification badge(s). Security personnel will not allow anyone to enter the sales rooms without an identification badge.

- Identification badges are non-transferable. Photo ID is required to pick up badges. Helpers
